<p>Strategic Planning Discussion in collaboration with the Fletcher Group, Amy Jeppeson and Nate Conklin. We discussed building another recovery center in Canyon County and building upon the existing resources at the Gem County recovery center. Services such as workforce/employment development services, housing, family supports, peer supports, and recovery coaching are important pieces to a recovery center that are needed now. Some examples: There are other states working on priority for recovery housing, second chances to decrease barriers to access employment for people who have trouble getting hired due to their background, there is a group designed for just fathers to support their children. We all agreed that we want to continue the forward momentum.</p>		<p>Have the board put together a gaps and needs analysis and start with three ideas to begin our focus that we could realistically do. As the subcommittee goes through the analysis, begin putting together micro, mezzo, and macro ideas attached to those three focus areas and which counties are priorities. The Fletcher Group will begin laying out a draft plan with some of the ideas that have been successful. The Fletcher Group will develop a MOU for the subcommittee to review and get into draft form for the Executive Committee to review at the August 28, 2024 meeting.
