Melissa Mezo mentioned that they were on a road trip to Payette, Adams, and Washington counties during their County Commissioner meetings. They were well received.

Marc Dominguez shared that they made a proposal for a Recovery Center and the Board is waiting to find out if this can be fit into their budget.

Melissa Mezo shared that there have been several letters of support and a letter from Ross Edmunds that have been used during their presentations to the County Commissioners.

Melissa Mezo was thankful for all the agencies that have provided these letters.

Judge Eames mentioned that he has not heard anything regarding the Recovery Center, but he will reach out to find out if this is on the horizon.

Melissa Mezo shared that they will continue to follow up with the Commissioners. The Board has been supporting many of the recovery events and supports through their history. She explained that Recovery Centers are intended to serve individuals and families who are in recovery, connecting them to resources. There are groups as well as individual counseling, peer support and recovery coaching.

There was a question about how the Board is able to fund small projects such as training for Peer Support.

Melissa Mezo mentioned that the applications came from the Children's Mental Health Subcommittee and were reviewed. Those applicants were then connected with BPA and Body and Mind who were offering the training. If you know anyone who is interested and they fall within the Region 3 boundaries please reach out to Melissa and she will get them connected.

Melissa Mezo walked through last year's Gaps and Needs report and the attendee's discussed the new gaps and needs report.

Melissa will review the discussion and send out the draft to the Board for review and feedback.

Resources mentioned in the Chat:

- [YouthROC](#) is Region 3's Youth Assessment Center. This program is great for youth ages 5-17 who are struggling and have behavioral health concerns, have gaps in basic living needs, and/or are experiencing safety concerns. The program connects the youth to a free assessment (CANS) and then a free case manager who supports them on an ongoing basis with their individual and family needs.
- The [Western Idaho Youth Support Center](#) is Region 3's youth crisis center. The youth crisis center serves youth ages 5-17 experiencing a behavioral health or associated crisis and need immediate in-person crisis de-escalation. Services are free and include behavioral health and medical assessments, crisis de-escalation, on-site peer support and case management, safety planning, food, clean clothing, a place to rest and recreate, shower, and connections to care. They are open 24/7/365, located at 308 E Hawaii Ave in Nampa, and services are free.
- The Idaho Behavioral Health Council's Crisis Center implementation team is working on the following goals: increasing regional access to youth crisis centers, increasing sustainability funding for crisis centers, increasing public awareness of crisis centers, and improving coordination between the crisis centers and the system as a whole.
- Region 2 is the only region that has three adult centers for rural access. The other six regions only have one adult community crisis centers, and only four regions have a youth crisis centers.
