Children's Mental Health Subcommittee Update	Joy Husmann provided an overview of committee progress. The committee has been working on its strategic plan. Development of an action plan is in progress. The group is looking to support existing efforts within the community. The May committee meeting will focus on assignments to support the action plan.	
IDHW Contract Updates and Next Steps	<ul> <li>Update on dead action item from January 2022 (Melissa Mezo)         <ul> <li>This item was planned to be revisited at the April meeting. The contract has since been terminated between SWDH and IDHW and no further action is needed on this item.</li> </ul> </li> <li>IDHW support and staffing updates (Jennifer Burlage) – IDHW will be hiring a part-time administrative support for the board. A member of the Executive Committee will be invited to participate in the interview process. IDHW plans to create a standalone website for the board, this is anticipated to go live at the end of May. SWDH will host any materials until the new site is launched.</li> </ul> <li>Aaron St. George requested that a board member be involved in the website development process to ensure the board can manage the site beyond IDHW support. Aaron also volunteered to donate the costs of a new domain and development of a website.</li> <li>Interim support (Melissa Mezo) – Joy and Melissa will be providing interim administrative support to the board. This will include new calendar invitations, development of meeting agendas, and minutes.</li>	IDHW will stop any progress on developing an external website on behalf of the board. Will await any future guidance from the board.  IDHW will pause its efforts to hire board support staff, they will wait for future guidance from the board.

#### 988 Transition Guide for Outpatient Providers

<u>Starting May 16<sup>th</sup> Region 3 Mobile Crisis after-hours calls (1700-0800 and all day on weekends and holidays) are being routed to the Idaho Crisis and Suicide Hotline (ICSH).</u>


<u>Starting July 16<sup>th</sup></u>, all Region 3 Mobile Crisis calls will be routed to the Idaho Crisis and Suicide Hotline 24/7. At this time, ICSH will become 988. <u>Mobile Crisis will continue to conduct field response.</u>

The Idaho Crisis and Suicide Hotline (ICSH/988) will de-escalate and handle all possible calls but will continue to send the following types of follow ups to MCU:

- Requests for consult
- Request for MCU complex follow up such as program applications for treatment
- Requests for welfare checks

Providers will reach a phone tree when calling Mobile Crisis. They will have two options: press 1 for crisis or 2 to leave a message for Behavioral Health. (This number can also be provided to clients to call as well)

- Option 1 will route to Idaho Crisis and Suicide Hotline (ICSH/988) and they will de-escalate, support, or provide resources and referrals. If there is a Mobile Crisis level of response needed, the Idaho Crisis and Suicide Hotline (ICSH/988) will reach out to Mobile Crisis for urgent follow up.
- Option 2 will send them to a voicemail for non-urgent follow up with expected follow up within 24 hours.
